## **Правила за организация и провеждане на спортни прояви в България в условия на Covid-19, извънредна епидемична обстановка и спецификата на съответната дисциплини по конен спорт**

Българска федерация конен спорт утвърждава следните правила за организация и провеждане на отделните прояви в България съобразно спецификата на съответната дисциплина.

### **1. Допускане до територията на състезанието**

До състезанието се допускат само състезатели и лица от техния антураж:

- които са безсимптомни (без хрема, повишена телесна температура и/или други симптом на настинка)
- които са нямали признаци на заболяване през седмицата предхождаща състезанието и дните преди него. В случай че са имали симптоматика са длъжни да декларират този факт.
- които през предхождащите състезанието 72 часа не са имали повишена (над 37 градуса) температура
- преболедувалите корона вирус лица са с два отрицателни Пи Си Ар теста и са били 30 дни в карантина след тях

### **2. Мерки по време на състезанието**

Организаторът на проявата разработва за всяко отделно състезание регламент и план включващ предвидените мероприятия за организация на съответната проява съобразен с приетите от правителството рестриктивни мероприятия:

- Организаторът-домакин на състезанието да определи Лице Отговорно за Контрол (ЛОК) по спазване на приетите мерки.
- Създаване условия за спазване дистанция между отделните лица на всички места на обекта като трибуна, основен плац, загряващ плац, места за хранене, трибуни, тоалетни и т.н.
- Изграждане места и осигуряване на дезинфекция: до загряващия плац, на трибуните, до местата за хранене, на входовете на всяка конюшна (палатка)
- Стая за изолация при възникване на заболяване на самото състезанието до идването на медицински екип



- Определяне правила за задължително ползване на маски и ръкавици на определени места и съоръжения.
- Организация на място за паркиране на транспортните средства и автомобилите
- Системи за комуникиране на участниците с офиса на състезанието, секретариата, съдийската кула и отделните спортни съоръжения
- Организация по контрола и ограничаване на достъпа за влизане и работа в конюшните
- Подаване на заявки за участие на състезатели и коне
- Правила за настаняване в хотел
- Правила и организация за хранене
- Правила за движение в рамките на обекта
- Правила за организация на ветеринарен преглед
- Правила за ползване плаца за загрявка
- Правила за строителство на паркури и трасета
- Правила за разглеждане на паркури и трасета

### **3. Задължения на Лицето Отговорно за Контрол (ЛОК) по спазване на приетите мерки**

#### **3.1. Превозни средства**

ЛОК организира посрещането и организира паркиране на камионите и транспортните средства за конете. Паркирането да бъде съобразено със спазването на дистанция минимум 3 м. между транспортните средства.

#### **3.2. Конюшни**

- Настаняване на конете в конюшните по предварително изготвен план съгласно заявките.
- Създаването на организация за контрол за достъпа в конюшните срещу предварително изготвени пропуски при не повече от два пропуска на кон.
- Влизането в конюшните става със задължително ползване на защитни маски, като отговорното лице е необходимо да организира и контролира съблюдаването на това изискване.
- Отговаря за организацията по дезинфекция преди и след състезанието за всяка конюшня. Осигуряване на дезинфектант за ръце на входовете на конюшната от момента на отваряне на конюшните до напускане на всички коне.
- Отговаря за организирането на условията за наличие на водата за поене и миене на конете, като създава организация за спазването на необходимата дистанция от 4 м. между конете и 1,5-2 м между хората. Дистанция от 4 м е



необходима при седлаене възсядане и разседлаване извън конюшните с оглед избягване и на инциденти. Ако оседлаването и почистването на коня е в конюшната, това може да става само в бокса, а не в коридора на конюшната.

### **3.3. Стая за изолация**

- ЛОК отговаря за определянето на стая за изолация при възникване на симптоми на заболяване по време на състезанието до пристигане на специализиран медицински екип.

### **3.4. Места за сядане и хранене**

- ЛОК отговаря за маркирането на местата за сядане за наблюдение на състезанието от състезатели, треньори и други лица, спазвайки физическа дистанция от минимум 1,5 м. между лицата
- Организира изхранването на хората, като създава организация за спазване изискващата се физическа дистанция между отделните клиенти, както и спазването на законовите изисквания за този вид дейност. Препоръчваме организация на открито и в посуда за еднократна употреба.

### **3.5. Хигиена**

- ЛОК обезпечават възможност за дезинфекция с препарат на ръцете и вода и сапун за миене.
- Определя тоалетните за ползване като съблюдава мерките за поединично ползване почистване и редовна дезинфекция. Задължителното почистване и дезинфекцията да се извършват на всеки час. Не се допуска сушене с духаща система. Навсякъде където е необходимо да се използват хартиени кърпи и салфетки за еднократна употреба. Всички книжни отпадъци да се изхвърлят в кошчета с капаци.
- Организира закупуване на защитни маски и ръкавици

### **3.6. Закупуване на фураж**

- ЛОК отговаря за организацията по закупуване и получаване на фураж или друго необходимо. Препоръчваме това да става поединично по часови график при задължително ползване на защитни маски.



#### **4. Офис и секретариат**

- Заявките за участие се подават по електронен път. Не се приемат заявки на място
- Офисът на състезанието организира своята дейност съгласно възможностите си. Препоръчваме намаляването до минимум на преките контакти. Влизане по един, задължително след дезинфекция и със защитна маска. Оборудване на офиса със защитни маски, ръкавици и дезинфектанти, като дезинфекцията се извършва след всеки клиент.
- Комуникацията със секретаря на състезанието да се осъществява по интернет или телефон: заявки, промяна старт, презаписване и т.н.
- При спешна необходимост директен контакт да се осъществява от разстояние минимум 1,5 метра. Задължително със защитна маска и дезинфекция на ръцете.

#### **5. Съдийско ръководство и организация на съдийската кула**

- Съдийската кула да бъде ситуирана с възможности за работни места за 4 човека, отстоящи един от друг на минимум 1.5 метра.
- При работата съдиите и всички технически лица в кулата (включително и в дисциплината обездка) задължително ползват защитни маски. При всяко влизане в съдийската кула съдиите извършват дезинфекция на ръцете си. Всеки съдия ползва личен хронометър и химикал. За предпочитане е да използват ръкавици.
- Съдията на камбаната и тайминг системата работи с тях след предварителна дезинфекция на пособията и ръцете си. До минимум да се намали ползването на листове и пособия, които са били в контакт с други членове на съдийската комисия.
- Радиостанцията за връзка със стюардите се дезинфекцира преди ползване и се ползва само от едно лице в съдийската кула.
- Секретаря, които е и говорител е задължен да спазва всички изисквания за съдиите. Работи с микрофон предварително дезинфекциран който не се ползва от друго лице.
- Съдиите по обездка и техните секретари да бъдат с предпазни маски.
- Лицата, които събират оценъчните листа по обездка да бъдат с ръкавици.



## **6. Ветеринарен преглед**

- Мястото за ветеринарен преглед трябва да дава възможност за ситуиране на трима души отстоящи на разстояние от 1.5 м.
- Пътека даваща възможност на кон и ездач да бъдат на разстояние от комисията минимум от 2 м.
- Проверяващия ветеринарен лекар и лицето получаващо паспортите задължително трябва да ползват защитни маски и ръкавици.
- Трябва да бъде определено място за проверка на паспортите и попълването им от ветеринарния лекар по възможност отделено от други лица.
- Препоръчваме ветеринарния лекар да ползва лична химикалка и ръкавици.
- Трябва да има обособено място при влизане в гейта за снемане на пулс.

## **7. Плац за загрявка**

- В плаца за загрявка да бъдат допускани не повече от 5 до 6 коня в зависимост от размерите му.
- Да няма близък контакт между загряващите състезатели и коне.
- В плаца да бъдат допускани по всяко време не повече от 4-ма души в това число и стюарда.
- Конегледачите и стюарда задължително да ползват защитни маски и ръкавици.
- Радиостанцията на стюарда е лична и предварително дезинфекцирана.
- На входа на плаца да има място за дезинфекция на ръце.

## **8. Строителство на паркури**

- Работниците и корсдизайнера трябва да ползват защитни маски и ръкавици.
- При всяко влизане на плаца да се извършва дезинфекция на ръцете или ръкавиците.
- Да се спазва разстояние от 1,5 между хората по всяко време.

## **9. Разглеждане на паркура**

- Паркура се разглежда при задължително ползване на маски.
- Да се спазва отстояние от минимум 1,5-2 м между участниците от различните отбори. Изключение за това условие треньор и ездач/и/ от един и същ отбор.
- Не се допускат други лица освен състезатели и треньори и съдии.
- Съдийската комисия може да прецени разглеждането на паркура да става по групи с оглед съблудване на необходимата дистанция

## **10. Награждаване**



- Не се извършва официално награждаване.
- Розетките, паричните награди и други се получават при получаването на паспортите.
- Паспортите се получават от офиса на състезанието при спазване на посочените в раздел офис мерки.

#### **11. Издръжливост**

- В дисциплината издръжливост всички лица от екипите в зоните за възстановяване и почивка да бъдат с маски.

#### **12. Обездка и всестранна езда**

- В тестовите по обездка съдиите и техните секретари да бъдат на разстояния от 1,5 – 2 м.
- При плацовете за загрявка да се спазват посочените по горе правила
- При разглеждане на кросовото трасе да се спазват правилата за разглеждане на паркури

#### **13. Други разпоредби**

- На база общия правилник на ФЕИ, съдийската комисия по медицински причини има право да отстрани от състезанието всеки един участник.
- Съдийската комисия има право да не допусне или спре от участие състезател, ако той или човек от неговия антураж не спазват тези или други разпоредби свързани с противоепидемичната обстановка.
- Организационния комитет следва да разпечата и залепи тези правила до конюшните, загряващия плац и обичайното място за поставяне на стартовите листа.

# Guidance for the use of the WHO Mass Gathering Sports Addendum Risk Assessment tools in the context of COVID-19

Guidance for organizers of sports events planning mass gatherings during the current outbreak of COVID-19

Routine planning for mass gatherings includes conducting risk assessments to determine the overall risk of disease spread. In view of the current outbreak of COVID-19, a disease-specific and event-specific risk assessment and mitigation checklist has been developed for use by host countries and organizers of mass gathering, to assess the specific risk of COVID-19.

This tool includes all factors from the general WHO risk assessment and mitigation checklist for mass gatherings as well as additional factors relating to sporting events, to enable event organizers to determine a more accurate overall risk score.

The following risk assessment and mitigation checklist should be used in conjunction with the WHO Mass Gathering Sports Addendum Guidelines. In order to accurately provide answers the following risk assessment and mitigation checklist, organizers must be knowledgeable on the current COVID-19 outbreak. The organizers should reference the daily global COVID-19 situation reports provided by WHO as well as the national COVID-19 situation reports, if available.

The tool must be completed in this Excel spreadsheet (see following tabs), as the scores are automatically calculated there. After the tools have been completed, the scores you receive in the Excel spreadsheet for both sections will need to be entered into the decision matrix found on the final tab ("Overall risk scores") for the overall risk score to be determined.

It must be ensured that this risk assessment is conducted with input from local public health authorities and that the necessary personnel with expertise in mass gatherings, risk assessment, epidemiology, and infectious disease control measures are included from the initial stages of planning.

For the overall determination, factors under consideration include:

- the current stage of the COVID-19 outbreak and known transmission dynamics
- the geographical distribution and number of participants, and their individual risk profile
- the risk assessment tool
- the mitigation measures that are currently in place or feasible

*It is important to remember that while mitigation measures can reduce the risk of COVID-19 infections, they cannot completely eliminate the threat. It is WHO's view that all countries with community transmission should seriously consider postponing or reducing mass gatherings that bring people together and have the potential to amplify disease and support the recommended best practice of physical distancing. Any decision will be supported through the use of WHO tools, in particular the Risk Assessment for Mass Gatherings during COVID-19.*

*If movement restrictions and further national measures have been established in the country, the WHO RA does not apply.*



## Mass gathering risk assessment for COVID-19: addendum for sporting events

The questions below will enable sport event organizers to review the additional considerations specific to sporting events involving mass gatherings, and thus inform their risk assessment of COVID-19 associated with the event. This will help organizers to understand and manage any additional risk from COVID-19.

The risk assessment should be reviewed and reassessed regularly during the planning phase and updated immediately prior to the transition to the operational phase, especially in light of the rapidly evolving nature of the outbreak. Reference should be made to the latest technical guidance and situation reports on the WHO website.

The risk assessment for COVID-19 associated with the sporting event must be coordinated and integrated with the host country's national risk assessment for COVID-19. The person completing the questionnaire should include input from the local public health authorities, consult WHO's latest technical guidance and ensure that there is an up-to-date evaluation of the epidemiological situation.

## Mass gathering mitigation checklist for COVID-19: addendum for sporting events

Mitigation measures assess the current effort and planning to reduce the risk of spread of COVID-19 disease for the event. As mitigation measures can reduce the overall risk of the mass gathering contributing to the spread of COVID-19, they should be taken into account after the risk assessment has occurred to gain a clearer understanding of the overall risk of transmission and further spread of COVID-19, should the mass gathering be held. Together with the risk assessment score, the mitigation measure will contribute to the decision matrix and influence the assessment of the overall risk of transmission and further spread of COVID-19 in relation to the mass gathering.

#### **IV. THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE**

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

In accordance with the FEI Code of Conduct for the Welfare of the Horse it is imperative that all Horses at FEI Events are physically fit and free from infectious disease before being allowed to compete.

### 4. Injury Surveillance

FEI Veterinary Regulations, **Chapter VIII**:

Horses participating in FEI Events are subject to injury surveillance protocols; and in the event of fatality, a post mortem examination.

### 5. Transport Of Horses

Horses must be fit to travel and be transported in suitable vehicles f. Any government requirements for disease testing and control must be requested well in advance, to ensure that the horse is in compliance by the time of arrival at the border of the country where the Event is taking place. Athletes, or their representatives, have the responsibility to comply with national legislation in both their country of origin and the host nation of the Event. Where necessary athletes must contact local government authorities or veterinary advisors for information regarding animal health requirements and transport legislation. Within the European Union (EU), this includes EU Council Regulation (EC) No 1/2005 concerning the protection of animals during transport within the Member States of the EU.

**6. Venue Arrival Information & Fitness To Compete**

**6.1 Passports. FEI General Regulations**

**Article 137**

**For all Horses on FEI Passports/FEI Recognition Cards issues, please address to your National Federation**

All Horses competing at FEI Events must be registered with the FEI.

FEI Passports or FEI Recognition Cards (for those Horses with a national passport approved by the FEI) are compulsory for FEI Events.

**NB:** Horses in CIMs, in their country of residence are not required to have an FEI Passport or FEI Recognition Card but must be properly registered with the FEI and identifiable (GRs. 137.2).

Athletes who do not present a Horse's Passport and/or Recognition Card, or one that is not correctly validated or fail to meet other passport requirements will be **subject to Sanctions in accordance with Annex VI of the FEI Veterinary Regulations** and may not be allowed to compete.

**NB:** for Horses permanently resident in a Member State of the European Union: all Horses must have a national EU passport in compliance with EU Regulations to which a FEI Recognition card is applied. The exception to this being Horses in possession of an FEI passport which has been continually revalidated without interruption.

**6.2 Vaccinations - Equine Influenza**

**FEI Veterinary Regulations Article 1003**

Horses competing at FEI Events must comply with the requirements for Equine Influenza vaccination in accordance with the Veterinary Regulations and as summarised below.

All FEI registered Horses intending to compete at FEI Events (including CIMs) must be vaccinated against Equine Influenza in accordance with these VRs. The exception being if the applicable domestic legislation prevents the use of Equine Influenza vaccines within the relevant territory.

### **6.3 Examination On Arrival**

#### **FEI Veterinary Regulations Article 1031**

On arrival at an Event venue all Horses must undergo an examination by a veterinarian to confirm their identification from their passport and micro-chip ID (where present), their vaccination status and general health. To protect all horses attending events, any Horse with a questionable health status, concerning vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue.

### **6.4 Horse Inspections**

#### **FEI Veterinary Regulations Articles 1034-1042**

All Horses will be assessed for their fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses not deemed fit to compete by the Inspection Panel will not be permitted to compete.

### **6.5 Limb Sensitivity Examination**

#### **FEI Veterinary Regulations Articles 1048-1053**

All Horses are subject to examination under the protocol for abnormal limb sensitivity throughout the period of an Event. For Jumping that includes, but is not limited to, between rounds and before the Jump Off. For Endurance that includes, but is not limited to, pre-ride, during the ride and after the ride. Horses may be examined once or on multiple occasions during the Period of an Event.

Horses may be selected for examination under the protocol randomly or they may be targeted. All Horses selected to be tested must submit promptly to the examination or are subject to immediate disqualification. There is no obligation to examine any specific number of Horses at an Event.

## **7 Equine Anti-Doping And Controlled Medication Programme (EADCMP).**

### **FEI Veterinary Regulations, Chapter VII**

#### **7.1 Sampling.**

##### **FEI Veterinary Regulations, Chapter VII**

All horses competing at FEI Events may be subject to sampling for the presence of FEI Equine Prohibited Substances in accordance with the FEI Equine Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures. Refer to FEI Financial Charges for details of fees relating to Equine and Human Anti-Doping program (EADCMP), which OCs/NFs have the right to charge to the athlete (applicable for all FEI events worldwide).

#### **7.2 Elective Testing.**

##### **FEI Veterinary Regulations Articles 1058**

Elective Testing may be carried out prior to an Event to check for the presence of Prohibited Substances. Please refer to <http://inside.fei.org/fei/your-role/veterinarians> for information and details.

### **7.3 Hyposensitivity Control System Examination** **FEI Veterinary Regulations, Annex VIII**

All horses competing in FEI Endurance events are subject to Hyposensitivity Control System Examination. Horses may be examined once or on multiple occasions during the Period of the Event and may be selected randomly and/or target tested by the Ground Jury and/or Veterinary Commission.

All horses selected to be tested must submit promptly to the examination. A refusal by the PR or his/her representative to submit a horse for examination will lead to disqualification and a yellow warning card. Withdrawal of the horse is not allowed once the PR or support personnel has been notified that the examination is to take place.

## **XIV. HUMAN ANTI-DOPING**

Athletes can be tested at any FEI Event, by the FEI or by other Anti-Doping Organisations with Testing jurisdiction. Organisers will have the responsibility to provide facilities and staff/volunteers to facilitate such Testing if requested by the FEI as outlined in article 22.3 of the FEIs' Anti-doping Rules for Human Athletes (ADRHA).

## XV. ADDITIONAL INFORMATION

### 1. THE FEI POLICY FOR ENHANCED COMPETITION SAFETY DURING THE COVID-19 PANDEMIC

The FEI Policy for Enhanced Competition Safety during the Covid-19 Pandemic (“Policy”) <https://inside.fei.org/fei/covid-19/return-to-play/policy-tools> is mandatory and applies for any FEI Event taking place **as of 1 July 2020**. The Policy has been developed based on currently accepted best practices by the WHO and US Center for Disease Control (CDC) and will be continually reviewed and updated as more information becomes available. It is not intended to replace the applicable guidance and policies from domestic government and health authorities, but to supplement their recommendations with sport specific considerations.

The OC shall submit the risk assessment and mitigation plan (including name and contact details of the person in charge) to the FEI as an annex to the Event Schedule, **at the latest ten (10) working days before the event's deadline for Definite Entries**.

Events for which the FEI has not received the documented risk assessment and mitigation measures plan in accordance with article 2.1.g) of the Policy **will be removed from the FEI calendar** in accordance with Article 112.3 of the FEI General Regulations.

#### **ASSUMPTION OF RISK / WAIVER OF LIABILITY**

In consideration of being allowed to participate in the Event and related activities, all Participants (as defined in the Policy) acknowledge, appreciate, and agree that:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. The Participants knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the OC or others, and assume full responsibility for their participation; and,
3. The Participants willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, a Participant observes any unusual or significant hazard during his/her presence or participation, the Participant will remove himself/herself from participation and bring such to the attention of the nearest official immediately; and,
4. The Participants, for themselves and on behalf of their heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE OC AND THE FEI, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event (“RELEASEES”), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

The Participants confirm to have read this release of liability and assumption of risk agreement, fully understand its terms, understand that they have given up substantial rights.

## **2. Insurances And National Requirements**

In exceptional circumstances, together with the approval of Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the Organiser may change the schedule in order to clarify any matter arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and they must be reported to the FEI Secretary General by the Technical Delegate.

### **2.1 ATHLETES, OWNERS AND SUPPORT PERSONNEL**

#### **2.1.1 Personal Accident and Health Insurance**

It is your responsibility as an Athlete/Owner/ Support Personnel to ensure that you have adequate personal accident insurance in place to cover your participation at FEI Events and in particular to insure against any personal injury or medical expenses arising from an accident, injury or illness which may occur at a FEI Event.

You should check with your National Federation to confirm if your National Federation's insurance policy (if any) covers personal accidents and/or illnesses which may occur when you are attending at/participating in FEI Events.

If your National Federation does not have a personal accident/health insurance policy or if the National Federation's insurance policy does not cover personal accident or health claims, then you should obtain your own personal accident and health insurance policy to cover your attendance/participation at FEI Events.

#### **2.1.2 Personal Property Insurance**

You should also ensure that you are insured against property loss, theft or damage which may occur at an FEI Event.

Again, the advice is to check with your National Federation to confirm if they have an insurance policy in place which would cover you in case of such property loss, theft or damage. If not, then you should obtain your own personal property insurance to cover such situations.

#### **2.1.3 Press Equipment**

Press equipment and other items left in the Press workroom, Press lockers, the Press Tribune or anywhere on the showgrounds are left entirely at the owner's risk. The Organising Committee does not accept any responsibility for any loss or damage to such equipment or items. Members of the Press are advised not to leave any equipment or personal items unattended.

## 2.2 ATHLETES AND OWNERS

### 2.2.1 Third Party Liability Insurance

As an Athlete/Owner you are personally responsible for damages to third parties caused by you, your employees, Support Personnel, your agents or your Horses. You are, therefore, strongly advised to take out third-party liability insurance providing full coverage in relation to FEI Events at home and abroad, and to keep the policy up to date.

The FEI and the Organiser will NOT be responsible for any damage caused to third parties by you, your employees, Support Personnel, your agents or your Horses.

### 2.2.2 Additional Liability Information

As an Owner you should ensure that your Horses are adequately insured against any injuries or illnesses they may sustain while participating at a FEI Event.

## 3. Protests / Appeals

To be valid, all Protests and Appeals must be made in writing and accompanied by a deposit of CHF150. – or equivalent.

## 4. Disputes

In the event of any discussion concerning the interpretation of the schedule (in translated languages), the English version will be decisive.

## 5. Modifications Of Schedule

In exceptional circumstances, together with the approval of Chefs d'Equipe and Ground Jury the OC reserves the right to modify the schedule in order to clarify any matter or matters arising from an omission or due to unforeseen circumstances.

Unforeseen circumstances do not include situations arising as a result of the OC altering the approved Schedule without FEI's authorisation. Any such changes must be notified to all competitors and officials as soon as possible and they must be reported to the FEI Secretary General by the Foreign Judge.

## 1. FEI Endurance Organisers' Protocol – 01/07/2020 to 31/12/2020

With an aim to further ensure the welfare of equine and human athletes at International Endurance Events, the safety of all participants and the implementation and respect of common principles of behaviour, fairness, and sportsmanship, the FEI has created this FEI Endurance Organiser's Protocol (hereinafter the "Endurance Protocol") to guarantee the correct and full application of the applicable FEI Rules and Regulations in your Events, in particular but not limited to, the FEI General Regulations, the FEI Endurance Rules, the FEI Veterinary Regulations, the FEI Anti-Doping Rules for Human Athletes and the FEI Equine Anti-Doping and Controlled Medication Regulations.

In order for the FEI to approve the competition schedules the Endurance Protocol **must** be signed once a year by the Organiser and the National Federation, listing the Event(s). By signing the Endurance Protocol (which will be incorporated into the competition schedule of your Event(s)) both aforementioned parties agree to comply with all applicable FEI Rules and Regulations, and in particular (but not limited to), with the following requirements:

1. Full cooperation must be given to the FEI Officials to ensure that they can perform their tasks according to the FEI Endurance Rules, in particular:
  - Ground Jury Art. – Art. 853
  - Technical Delegate – Art. 852
  - Veterinary Commission – Art. 854
  - Chief Steward Art. – Art. 855
  
2. Full cooperation must be given to the FEI Independent Governance Advisors (IGAs) to ensure that they can perform their tasks according to the FEI Endurance Rules Art. 856.
  
3. The welfare of the horse must be a first priority and you must allow the FEI Officials to take all necessary measures to safeguard it, as per the FEI Endurance Rules, including but not limited to:
  - Loops of the course must not be specially designed and/or constructed to encourage high speeds - Art. 814.4.5
  - Allowing for the reduction of the pulse criteria - Art. 816.9. The pulse criteria may be reduced during the ride if, in the opinion of the President of the Veterinary Commission in consultation with the Foreign Veterinary Delegate, the President of the Ground Jury and the Technical Delegate they believe there is a danger to the safety of the Horses.
  - The Veterinary Commission has absolute control on all matters concerning horse welfare - Art. 854.1
  - The Technical Delegate or the Ground Jury together with the Veterinary Commission can decide to modify the length of timed holds according to extreme weather conditions or other exceptional circumstances.... - Art. 816.9.2.



4. The safety of the athletes, FEI Officials and public must be safeguarded at all times and FEI Officials must be allowed to take all necessary measures to ensure safety, as per the FEI Endurance Rules/FEI GRs:
- The field of play - Art. 813
  - Number of crew members allowed - Art. 813.2.2
  - Horses must remain capable of being clearly observed at all times - Art. 813.5
  - Permitted Assistance during Event or on Course - Art. 822.4
  - Prohibited Assistance - Art. 822.5
  - Postponement and/or cancellation of an Event - FEI GRs 109.12
5. The FEI Officials' Code of Conduct must be adhered to including the obligations and restrictions pertaining to the "Endurance Official's Per Diems".

Any breach of the FEI Rules and Regulations will be prosecuted according to the FEI Legal System (Chapter VIII of the FEI General Regulations).


